**Treasurer's Report**

- Mimi went over proposed 2013-14 budget in detail. Motion to approve by Camilo . Seconded by Robin. All approved. The 2013-14 budget is approved pending small changes by Mimi (possible \$933 over)
- Checking Account Balance -- \$10,230.43 (3k allocated for guitar and band accounts)
- Marching Band Fees -- \$ outstanding (Not available)
- Concert/Jazz Band Fees -- \$xxxx jazz bands, \$xxxx concert bands outstanding. (Not available)
- An amount of \$200 and \$75 scholarship for Summer in the City. Lisa motioned to approve. Seconded by Laura. Approved by all.
