Waiver Committee: still evolving

Budget Committee: Reported that a realistic income line for each group has been included. In order for the budget to be completed the calendar needs to be finalized. Each line is very detailed-used last year's numbers. We had an actual bus bid this year, West Valley won. Purchases not being repeated this year were removed. It includes staffing and fees for entrance to festivals.

Expense questions:

**Line 2618** - We typically spend \$14-20K on equipment every year so proposing a large purchase instead. The value of the equipment is \$158,000 but we will only be paying \$118,000 which works out to \$23,600 a year for five years. This equipment will be used by all of our band programs. Buying new equipment will also cut down on repair expenses and time. We have several pieces that are on their last legs (the vibraphones won't even make it out to the FB field). The payments will be due in June each year.

**Line 2603** – This would partially cover a student's expenses if an emergency arises for someone who makes payments from the beginning and then isn't able to finish them.

Income questions:

This budget will be voted on but throughout the year can be adjusted. If a fundraiser isn't working we would be able to change it or add something else to subsidize the funding.

**Motion** to approve the 2015-2016 Budget as written except for Lines 1104, 1105 and 4003 for Winter Programs– Gretchen Ehlers; motion 2nd – Patty Larkin ; All in favor no opposed or abstaining.

Payment Schedule for 2015-2016 will be similar to last year. An email will be sent out to membership.

Color Guard \$900; Marching Band \$950; Concert only \$125
